# THE BAR COUNCIL OF INDIA

The Bar Council of India is a statutory body created by Parliament to regulate and represent the Indian bar. BCI performs the regulatory function by prescribing standards of professional conduct and etiquette and by exercising disciplinary jurisdiction over the bar. BCI also sets standards for legal education and grants recognition to Universities whose degree in law will serve as qualification for enrolment as an Advocate.

In addition, BCI performs certain representative functions by protecting the rights, privileges and interests of advocates and through the creation of funds for providing financial assistance to organise welfare schemes for them.

**The Bar Council of India was established by Parliament under the Advocates Act, 1961. The following statutory functions under Section 7 of the act cover the Bar Council's regulatory and representative mandate for the legal profession and legal education in India:**



1. To lay down standards of professional conduct and etiquette for advocates.
2. To lay down procedure to be followed by its disciplinary committee and the disciplinary committees of each State Bar Council.
3. To safeguard the rights, privileges and interests of advocates.
4. To promote and support law reform.
5. To deal with and dispose of any matter which may be referred to it by a State Bar Council.
6. To promote legal education and to lay down standards of legal education. This is done in consultation with the Universities in India imparting legal education and the State Bar Councils.
7. To recognise Universities whose degree in law shall be a qualification for enrolment as an advocate. The Bar Council of India visits and inspects Universities, or directs the State Bar Councils to visit and inspect Universities for this purpose.
8. To conduct seminars and talks on legal topics by eminent jurists and publish journals and papers of legal interest.
9. To organise legal aid to the poor.
10. To recognise on a reciprocal basis, the foreign qualifications in law obtained outside India for the purpose of admission as an advocate in India.
11. To manage and invest the funds of the Bar Council.
12. To provide for the election of its members who shall run the Bar Councils.



## **The Bar Council of Maharashtra & Goa.**

The Bar Council of Maharashtra and Goa is constituted under section 3(1) (ccc) of the Advocates Act, 1961 for the States of Maharashtra and Goa, Union Territories of Dadra and Nagar Haveli and Daman and Diu. For all these States and Union Territories, the Bar Council is known as the Bar Council of Maharashtra and Goa. The Bar Council enrolls Advocates on its roll and grants 'Sanad'/'Licence' to practice law in the above territories. The Bar Council has a disciplinary jurisdiction over all the Advocates on its roll. The Bar Council regulates and maintains the standards of professional conduct and etiquette for the Advocates. It also regulates the standards of legal education within its territory.

## Question Paper Pattern for University Written Examination (80 Marks)

The question paper for University written examination of each subject, except for Practical Training Paper IV- Moot court Exercise and Internship shall be as under.

### (1) Part A Question (45 Marks)

Part A of question paper shall consist of essay type questions or questions of critical comments Depending on the nature of subject. A student has to answer the question with critical evaluation. There shall be five questions and the student has to answer any three questions. Each question shall be for 15 marks.

### (2) Part B Questions (20 marks)

Part B of question paper shall consist of short essay type questions depending on the nature of subject.

A student has to answer the questions explaining concepts with illustrations. There shall be four questions and the student has to answer any two questions. Each question shall be for 10 marks.

### (3) Part C Questions (15 marks)

Part C of question paper shall consist of short answer questions or solving of hypothetical problem, etc.

There shall be five questions and the student has to answer any three questions. Each question shall be For 5 marks.

NOTE: The Question paper pattern given herein may be changed or altered depending on the nature of subject example non-law subjects. The question paper pattern given herein may be changed or altered by the University at any time without prior information to the students.





# ACADEMIC RULES & REGULATIONS

## Standard Of Passing For B.A. LL.B. Course

- (1) In case of any subjects of B.A. LL.B. course a student must obtain not less than 40 marks to pass a Subject.
- (2) The Total marks of a subject, except for practical training subjects, shall be computed by adding marks of University written examination and internal assessment. There shall be separate passing for University written examination and internal assessment of a subject. A student must obtain not less than 32 marks to pass University written examination of a subject. A student must obtain not less than 8 marks to pass Internal assessment of a subject
- (3) The total marks of practical training subjects, except for Practical Training Paper IV-Moot Court exercise and Internship, shall be computed by adding marks for two components (a) University written examination and  
(b) Written submissions and viva voce examination. There shall be separate passing for these two components of a Subject. A student must obtain not less than 8 marks to pass a written submissions and viva voce examination of a subject.
- (4) The total marks of Practical training paper IV-Moot court exercise and internship shall be computed by adding marks for two components-
  - a) Moot court exercises, observance of trials, pre-trial preparations activities, and
  - b) Written submission and Viva voce examination. There shall be separate passing for these two components of a subject, A student must obtain not less than 32 marks to pass in a moot court exercises, observance of trials, pre-trial preparations activities of a subject. A student must obtain not less than 8 marks to pass a written submissions and viva voce examination of a subject.
- (5) A student shall be declared as passed in a particular year or class, if he/she have passed in all the Two terms or semesters of a year or class taken together.
- (6) There shall not be a separate passing for a single semester or term examination.
- (7) The pass class shall be awarded to the student if he / she have passed in all the subjects of two terms or semesters of a year or class taken together.
- (8) A student shall be entitled to the benefit of grace marks or additional marks for extracurricular activities as per University rules.
- (9) The rule of scaling down of internal assessment marks shall be applicable, if percentage of internal assessment marks exceeds percentage of University written examination marks by more than 15%. The difference between the percentage of University written examination marks and percentage of internal assessment marks of a Student for any subject shall not be more than 15%. If the percentage of marks obtained by a student for any subject in internal assessment exceeds the percentage of marks obtained by him/her in University written Examination by more than 15% the marks obtained by him/her in internal assessment shall be brought down to That extent.
- (10) The rule of scaling down of internal assessment marks shall not be applicable to practical training subjects.
- (11) The pass class shall be awarded to the student for the year or class as under -

S.No	Percentage of Marks	Class
(I)	Aggregate 40% and more but less than 50%	Pass Class
(II)	Aggregate 50% and more but less than 55%	Second Class
(III)	Aggregate 55% and more but less than 60%	Higher Second Class
(IV)	Aggregate 60% and above but less than 70%	First Class
(V)	Aggregate 70% and above	Distinction





## ELIGIBILITY FOR AWARD OF DEGREE

- (1) A student passing examination of third year of B.A.LL.B. shall be eligible to obtain the first degree of BA under the Integrated B. A. LL. B Course provided that he/she has passed examination of second year of B.A.LL.B., course provided that he/she has passed examination of second year of B.A.LL.B. Such a degree of B.A. shall not entitle the student to enroll as an advocate.
- (2) A student of B.A.LL.B. Course passing examination of all the year or classes, divided in ten semesters, shall be eligible to obtain the B.A.LL.B. Degree.

## DURATION TO COMPLETE ENTIRE COURSE

A student of BA. LL.B. Course, in order to become eligible for award of the degree, must pass in all the subjects, divided in ten semesters, within a span period of TEN academic years including academic year in which he/she was admitted to first year of the course. No student shall be admitted as a candidate for any examination of the said course after the said period of ten academic years unless he/she is readmitted to the course as a fresh candidate.

**Explanation:** For a student from 2003 Pattern admitted in revised curriculum, 2017 pattern under the rules of Equivalence, the duration to complete remaining course, shall be proportional to the total duration to complete entire course given above. Thus for example:

If a student of 2003 Pattern is admitted in second Year B.A. LL.B. Of 2017 Pattern, his/her duration to complete the course shall be eight academic years including academic year in which he/she was admitted to Second Year B.A. LL.B.

# ACADEMIC RULES & REGULATIONS

As mentioned in Circular No 230 of 2003 of University of Pune - Ref. No. ICB/3524 dated 12-6-2003). Semester Scheme for B.A. LL.B., (Five years Law course) from Academic year 2003-2004. The Rules of Standard of Passing The examination pattern has been simplified for the semester scheme & it shall be as follows :

A) Since one subject shall have only one paper during any session, all candidates regular, repeaters of all semesters will appear for the same paper.

B) The papers for the subjects of B.A. LL.B (5 year) course will however have different code numbers according to the course for identification.

## ENTITLEMENT TO APPEAR AT THE ACADEMIC YEAR B.A. LL.B. (5 YEAR) INTEGRATED LAW COURSE

A candidate who has completed his term for Semester I, III, V, VII and IX of the Five year B.A.LL.B. Course and has paid examination fees for such Semester Examination, shall be entitled to appear for any or all of such papers respectively along with the Semester II, IV, VI, VIII or X examination respectively.

Any student who has appeared for Semester I, III, V, VII or IX Examination of the five year B.A. LL.B., courses shall be entitled to re-appear for all or any of the papers along with the Semester II, IV, VI, VIII or X examination for improving his marks.

### i. Exemption –

A Candidate who obtains at least 50% of the full marks in a paper shall at his option be exempted from that paper at a subsequent examination. He / She shall however have to pass in the remaining paper or papers in accordance with the standard of passing laid down above. The benefit of exemption so earned may be available for six years only.

### ii. First-Second Class –

At the end of the academic year, those of the successful candidates who obtained 50% or more of the total marks will be placed in the Second Class, and those who obtain 60% or more of the total marks will be placed in the First Class, and those who obtain 70% or more marks will be placed in First Class with Distinction.

### iii. Allowed to Keep Terms –

A candidate who obtains at the 1st, 2nd, 3rd year of B.A. LL. B. or 4th year of B.A. LL. B. (Five year) B.A. LL .B. Course hereinafter earlier year 50% of the full marks in the number of subjects given below out of the total number of papers prescribed for the respective academic year shall be allowed to keep terms respectively for next year i.e. the 2nd, 3rd year of B.A. LL. B. and 4th and 5th year B.A. LL.B., Examination i.e. ATKT for 1/3 of the total subjects.

1st B.A. LL.B., Examination - 4 subjects

2nd B.A. LL.B., Examination - 4 subjects

3rd B.A. LL.B., Examination - 5 subjects

4th B.A. LL.B., Examination - 5 subjects

Provided however, that he shall not be declared to have passed the examination of such next year, i.e. 2nd and 3rd year of B.A. LL.B., and 4th and 5th year of B.A. LL.B., unless he has passed such subjects and the remaining papers in the examination of such previous year according to the standard of passing laid down above.

## RULES OF ATTENDANCE AND PRACTICAL TRAINING

### CLASS ATTENDANCE

Students shall attend at least 80% of lectures delivered in each subject/semester. Students with less than 75% attendance are not eligible to write examinations at the end of the semester.

## TUTORIALS FOR B.A. LL.B. COURSE

Students shall write and attend the prescribed number of tutorials for each year to the satisfaction of the faculty.





## JOURNAL WORK AND VIVA-VOCE EXAMINATION FOR B.A. LL.B. COURSE

Under the scheme of Practical Training Programme, each student shall compulsorily maintain a Journal as may be prescribed by the institution for the clinical work done by him and from time to time regularly record in it the work allotted to and done by him in his own handwriting and the dates thereto under his signature and the same be scrutinized and counter signed from time to time by concerned Professor-in-charge.

The journal shall be submitted to the institution for assessment. The Professor-in-charge or some other examiner or a panel of examiners from time to time or at the end of the term as per the discretion of the Principal of the College, shall assess the journal.

As per the syllabus prescribed for practical training paper, a Viva-Voce Examination shall be held on behalf of the University by a committee of two examiners (one external and one internal) to be appointed by the University who will ask questions to the students on the basis of the clinical work done by them and marks will be allotted to them accordingly.

## COURT VISITS / ATTENDANCE AT LAWYER'S CHAMBER

Students under the supervision of a Professor-in-charge shall visit at least three of the following places during such working day and timing as may be decided by the institution. The object of this course is to enable the students to understand the actual working in some of the departments and the documents maintained by them with a view to familiarise them.

The Visits will be to any of the following places –

1. Office of the Registrars, Clerks of Courts
2. Nazirs, Record Keepers, etc in courts
3. Police Station
4. Office of the Sub-registrar under the Indian Registration Act
5. Prison / Jail / Sub-jail

## ATTENDANCE IN COURTS

Each student shall be required to attend at least two cases or proceedings or interim petitions of courts, as far as possible from start to finish, arising out of the following:

1. Civil Suits
2. Criminal Cases
3. Sessions Cases
4. Small cause court proceedings or
5. Proceedings before a Co-operative court or a Labour court, or a Revenue court or any other court as may be decided by the Professor-in-charge
6. Field visit to local areas and villages for Free Legal Aid Activities

Students shall be required to make their own notes and observations about the proceedings so visited and attended by them including the facts of the proceedings, legal issues involved and record them in the journal maintained by them. The journal so maintained for this purpose shall be assessed for the purpose of allotting marks under practical training paper.

## ATTENDANCE AT LAWYER'S CHAMBER

Students under practical training paper shall attend the offices of advocates on such days and during such timings as the concerned Advocates may suggest. The object of this course is to enable a student to make himself conversant with the working in an Advocates office as to how he takes instructions from clients and so on. The observation made by the student shall be recorded in the journal under practical training paper and the same shall be assessed for allotment of marks.

An applicant who has successfully completed Senior Secondary School Course (10+2) or equivalent (such as 11+1, 'A' level in Senior School Leaving certificate course) from a recognised University of India or outside or from a Senior Secondary Board or equivalent, constituted or recognised by the Union or by State Government or from any equivalent institution from a foreign country recognised by the Government of that country for the purpose of issue of qualifying certificate on successful completion of the course, may apply for and be admitted into the programme of the Centres of Legal Education to obtain the integrated degree in law with a degree in any other subject as the first degree from the University whose such a degree in law is recognised by the Bar Council of India for the purpose of enrolment.

An applicant who has successfully completed Pre-University course or Senior Secondary School course ('+2') or equivalent such as (10+1), 'A' level in Senior School Leaving Certificate Course) from a recognized University/Institutions of India or outside or from Senior Secondary Board or equivalent, constituted or recognized by the Central or State Government/s of India or from any equivalent institutions from a foreign country recognized by the government of that country for the purpose of issue of International qualifying certificate equivalent to 10+2 on successful completion of the course, may apply for and be admitted into the course.



## EXPLANATIONS

Provided those applicants who have obtained 12 Std./Higher Secondary Pass Certificate/First Degree certificate or equivalent course through distance or correspondence method, only after passing the basic qualifications (i.e. Secondary Schooling /10th Std. in Regular mode) for prosecuting such correspondence/distance 12th Std./Higher Secondary schooling courses, shall also be considered as eligible for admission to the 5 years LL. B. courses.

Provided further that the applicants who have obtained 12th Std. or Higher Secondary schooling through open Universities system directly without having basic qualification (i.e.10th Std. in regular mode) prescribed for prosecuting such studies are not eligible for admission to the 5 years LL.B. course.

An applicant who has passed the 11th/12th/Pre Degree Course examination from State/Central Boards of Schooling or from Open Schooling System recognized & established by the Government of the State/India or International Board of School Education, after prosecuting the basic course of studies in the pattern of 1st to 10th standards in Regular mode, at Secondary Schooling is eligible for admission to five-year Integrated LL. B. Course.

The applicant who has passed the prescribed basic qualification i.e. 10th Std./ Secondary Schooling Certificate Examination, in a single sitting examination, without having basic qualification (i.e.1 to 9th std. of schooling) is not eligible for admission to five year Integrated LL.B. Law Courses.

## PROHIBITION TO REGISTER FOR TWO REGULAR COURSES

No student shall be allowed to simultaneously register for a Law degree programme with any other graduate or post graduate or certificate course run by the same or any other university or an institution for academic or professional learning excepting in the integrated degree programme of the same institution. Provided that any short period part time certificate course on language, computer science or computer application of an institute or any run by a centre for Distance Learning of a University however, shall be exempted.

## MINIMUM MARKS IN QUALIFYING EXAMINATION FOR ADMISSION

Bar Council of India may from time to time, stipulate the minimum percentage of marks not below 45% of the total marks in case of general category applicants and 40% of the total marks in case of SC and ST applicants, to be obtained for the qualifying examination, such as +2 examination in case of integrated five year course for the purpose of applying for and getting admitted into a Law degree programme of any recognised University in either of the streams. Provided that such a minimum qualifying marks shall not automatically entitle a person to get admission into an institution but only shall entitle the person concerned to fulfil other institutional criteria notified by the institution concerned or by the Government concerned from time to time to apply for admission.

Course.

## PROHIBITION AGAINST LATERAL ENTRY AND EXIT

There shall be no lateral entry on the plea of Graduation in any subject or exit by way of awarding degree splitting the integrated double degree course, at any intermediary stage of integrated double degree course." However, a University may permit any person to audit any subject or number of subjects by attending classes regularly and taking the tests for obtaining a Certificate of Participation from the University/Faculty according to the rules prescribed by the University from time to time and give a Certificate therefore.

## SURYADATTA HALL OF FAME

### “RECIPIENT OF SURYADATTA NATIONAL LIFETIME ACHIEVEMENT AWARD 2010”



***Hon'ble T. S. Krishnamurthy***  
*For Excellence in the field of Law & Judiciary*

Taruvai Subayya Krishnamurthy was born in the year 1941. He is a former Indian Revenue Service officer who served as 13th Chief Election Commissioner (C.E.C) of India (February 2004 - May 2005).

Krishnamurthy won gold medals in History, Economics and Political Science at Mysore University. He also completed a Masters in Fiscal Studies from the University of Bath, U.K.

Krishnamurthy started his career as a probationary officer at the Bank of India (prior to nationalization) at the age of 19. He joined the Indian Revenue Service in the batch of 1963, subsequent to which he was posted as Income Tax Officer in Madras. Having served number of ministries in New Delhi including Shipping and Finance, he was deputed as a Deputy General Manager with the Hindustan Shipyard Limited in Visakhapatnam. One of the key jobs he has handled was that of Chief Commissioner of Income Tax in Bombay.

As Secretary, Department of Company Affairs, he is credited with setting up of Investor Education and Protection Fund set up from unclaimed dividends of companies.

He has also served as an IMF advisor in Ethiopia and Georgia. As Chief Election Commissioner he was an observer to the elections in Zimbabwe and the U.S Presidential Elections in 2004. In 2005, Krishnamurthy was appointed by the Supreme Court of India to conduct the elections to the Board of Control for Cricket in India (B.C.C.I) in order to ensure free and fair polls amidst the different factions within the BCCI.

His main assignment as C.E.C was to oversee the 2004 elections to the Lok Sabha. He had earlier served in the Election Commission of India as a commissioner since January 2000.

Post his retirement, he is a board member of various companies and NGOs, most notably, he was the Chairman of Bharatiya Vidya Bhavan, Chennai Kendra. He is the author of the book “Miracles of Democracy”, published in August 2008.





## “RECIPIENT OF SURYADATTA NATIONAL LIFETIME ACHIEVEMENT AWARD 2015”



***Hon'ble Justice Shri B. N. Srikrishna***  
***(Retd. Justice Supreme Court)***  
***For Excellence in the field of Law & Judiciary***

Justice B.N. Srikrishna was born in the year 1941. After graduating with a degree in Science, he went on to obtain his LL.B and later LL.M from the Government Law College and the University of Mumbai, standing second in the entire University.

He enrolled as an advocate of the Bombay High Court in the year 1962 specialising in the field of Labour and Industrial Law and designated as a Senior Advocate of the Bombay High Court in the year 1987. He was counsel for a large number of employers both in the public and private sector and appeared in a number of cases in the High Courts and the Supreme Court, which laid down fundamental principles of labour law.

Justice B.N. Srikrishna's name is synonymous with the commission of enquiry he headed, specifically the report he submitted in February 1998 pertaining to the riots that shook Mumbai in December, 1992-93; that generated widespread debate in India and abroad.

He was appointed by the Supreme Court of India in February/March 2009 to enquire into the incidents of violent clashes between lawyers and police in the premises of the Madras High Court, Chennai. He was also appointed by the Government of India as Chairperson of the Committee for Consultations to consider the demand for bifurcation of the State of Andhra Pradesh.

He was appointed as Chief Justice of the High Court of Kerala in September 2001 and as Honourable Judge of the Supreme Court of India in October 2002, which office he demitted in May 2006. He was also the Chairman of the Sixth Central Pay Commission. He was appointed the Chairperson of the Citizens' Committee for monitoring Security Issues in Mumbai by the High Court of Bombay. He was the Chairperson of the Financial Sector Legislative Reforms Commission appointed by the Government of India.

He was invited by the United Nations High Commissioner for Refugees to attend a seminar on refugee laws at Delhi and the international conference on the subject in Geneva and Berne in October 2000 and by the Universities of Berkeley U.S.A., Bar Ilan Israel and Oxford U.K. to deliver lectures on Socio-legal subjects.

Justice B.N. Srikrishna is currently occupied with arbitral and consultative legal practices since his retirement from the Supreme Court in May 2006.





## SURYADATTA HALL OF FAME

### “RECIPIENT OF SURYADATTA NATIONAL LIFETIME ACHIEVEMENT AWARD 2012”



***Hon'ble Justice Shri. V. S. Sirpurkar***  
***For Excellence in the field of Law & Judiciary***

Hon'ble Justice Shri. V. S. Sirpurkar is the only Judge in India who has worked in all the three chartered High Courts namely, High Court of Bombay, Madras High Court and Calcutta High Court.

He was born in the year 1946 in a family of lawyers. He topped in the Chandrapur District in Matriculation and thereafter joined Morris College and Law College. He practiced law at the Nasik High Court on Constitutional, Civil and Criminal sides. He was elevated as a Judge of the Bombay High Court in 1992 and later moved to Madras as a Senior Judge and held the post of Executive Chairman of the TamilNadu State Legal Services Authority setting up Lok Adalat Bhavans in 14 districts of Tamil Nadu.

He invented Special Adalats such as Bank Adalats, Tax Adalats and Pension Adalats. He also initiated the opening of the Judicial Academy for Tamil Nadu and started one in West Bengal. He was co-opted as a Member of the Legal Education Committee of the Bar Council of India, New Delhi.

He was elevated as Chief Justice, High Court of Uttaranchal, where he started the Uttaranchal Judicial and Legal Academy besides establishing a number of Law courts and pioneering the idea of combining legal help with medical help that was a boon to the poor in hilly areas. He later assumed office of the Chief Justice of the High Court in Calcutta.

He led a delegation of International Council of Jurists to China wherein the Judges and Bar Leaders from various countries like India, Maldives, Sri Lanka, Turkey and UK participated. He represented High Courts and the Supreme Court of India in the International Conference of Jurists for Judicial Reforms organized by the International Council of Jurists and The Hon'ble Society of Lincoln's Inn, London.

He was nominated as Chairman of the Management Council and Administrative Committee of the India Law Institute. He was instrumental in starting a law college at Indian Institute of Technology at Kharagpur, thus combining Legal training with the Technological aspect.

After coming to the Supreme Court Justice Sirpurkar wrote a number of landmark judgements in the field of Taxation, Central Excise, Customs, Criminal Laws, Land Acquisition and Hindu Laws. Some of his landmark and celebrated judgements have been pertaining to the Red Fort Attack Trial, Kerala Illicit Liquor Scandal, and others related relating to subjects of education, government services, rent control, revenue laws, contempt laws, tax laws and laws relating to religious trusts.





## “RECIPIENT OF SURYADATTA NATIONAL LIFETIME ACHIEVEMENT AWARD 2016”



***Hon'ble Justice Shri. Parshuram Sawant***  
***(Retd..)***  
***For Excellence in the field of Law & Judiciary***

Justice P. B. Sawant was born on June 30, 1930. Mr. Sawant started his career as a lecturer in New Law College, Bombay, in 1965, teaching Private International Law and Constitutional Law. He was appointed to the Bombay high court in 1973, he was elevated to Supreme Court on October 6, 1989. He retired after six eventful years at the apex court on June 29, 1995, but continued to be active in public life for the next 25 years.

Among the landmark judgments which he authored as part of the constitution benches, the decisions in Mandal and S. R. Bommai cases stand out. He was also of the view that the constitution empowers the Centre to satisfy itself completely about the relevant facts in a state from sources other than the Governor.

Justice Sawant once said a judge should develop a strong sense of smell. “If something stinks, then he or she must be extra careful,” he said, emphasising how right judicial instinct and skill of the judiciary could stop the misuse of the Public Interest Litigations (PIL) and restore it to its pristine character.

Justice Sawant was an advocate for pro-downtrodden, liberal judicial activism and was a leader of the PIL movement in Maharashtra.

Justice Sawant was the chairman of the inquiry committee set up to investigate the charges against Justice V. Ramaswami, the first judge to face impeachment motion in Parliament, in 1991.

Justice Sawant served as the Chairman of the Press Council of India after his retirement. During his term, he was the architect of the guideline that no newspaper shall publish exit-poll surveys, however genuine they may be, till the last of the polls is over. This was because he believed that the media should not allow themselves to be used for distortions and manipulations of the elections, and should not allow themselves to be exploited by interested parties.

Adv. Ujjwal Nikam is an Indian special public prosecutor who has worked on prominent murder and terrorism cases. He helped prosecute suspects in the 1993 Bombay bombings, the Gulshan Kumar murder case, the Pramod Mahajan murder case, and the 2008 Mumbai attacks. He was also the special public prosecutor in the 2013 Mumbai gang rape case, 2016 Kopardi rape and murder case. Adv. Ujjwal Nikam argued on behalf of the state during the 26/11 Mumbai attack trial.

Nikam was born in Jalgaon, Maharashtra, to Marathi parents. His father, Deoraoji Nikam, was a judge and barrister, and his mother was a homemaker.

After receiving his Bachelor of Science degree, he earned a law degree from the K.C.E. Society's S. S. Maniyar Law College in Jalgaon. His son, Aniket, is also a criminal lawyer in High Court Mumbai.

Nikam began his career as a district prosecutor in Jalgaon and worked his way up to state and national trials. In a 30-year career, he has secured 628 life imprisonments and 37 death penalties.

Nikam was awarded the Padma Shri by the Government of India in 2016.

He has been given a security detail with a classification of Z+, the second highest level of security in India.

In December 2010, Nikam represented the Government of India at a worldwide convention on terrorism held at the United Nations in New York.

Parasaran has received the B.A. (Economics) First Class from the University of Madras in 1981, a Bachelor of Law degree from Faculty of Law, University of Delhi in 1984 and a Master of Laws from the University of Cambridge.

In February 2013 he was appointed the Solicitor General of India and continued in this post till May 2014. He served as part of the Congress led UPA 2 government. Previously he held the post of Additional Solicitor General of India for nine years.

Parasaran has represented the Government of India in landmark cases. He has also appeared in the Commission of Inquiry, which probed into the Boeing 737 crash in Mangalore.

Satyanarayanan was born on 5 February 1948 in Mumbai to Sushila and Vasudev Mandake. Her father was a police officer. She studied in Mumbai, Pune and Nashik, graduating from the Delhi School Board with a focus on Sanskrit. She entered the Indian Administrative Service after completing undergraduate and postgraduate degrees.

During her career as a civil servant, she held posts in the Home, Forest, and Social Welfare departments in the Maharashtra Government, and retired as the Additional Chief Secretary (Revenue) in 2009. She served as the Principal Secretary for the Shiv Sena-BJP coalition government from 1995 to 1999. She also served as the Director-General of Information and Public Relations for the Maharashtra government.

After her retirement from civil service, she was appointed as the State Election Commissioner in Maharashtra and held the position until July 2014. The 2012 local elections in Maharashtra were conducted during her tenure.

Satyanarayanan wrote extensively in Marathi, with seven novels and ten volumes of poetry published at the time of her death. She also wrote two memoirs.

In 2017, Satyanarayanan composed a song in honor of the Mumbai Fire Brigade, at the request of the Chief Fire Officer. The song, 'Let's Go, Let's Go' was adopted by the Mumbai Fire Brigade at a special ceremony held at the Gateway of India.

***For excellence in the field of Public Service***

Kiran Bedi, an Indian social activist, former-tennis player is the first woman in India to join the officer ranks of the Indian Police Service (IPS) in 1972 and was the 24th Lieutenant Governor of Puducherry from 28 May 2016 to 16 February 2021. She remained in service for 35 years before taking voluntary retirement in 2007 as Director General, Bureau of Police Research and Development.

As a teenager, Bedi was crowned the national junior tennis champion in 1966. Between 1965 and 1978, she won several titles at various national and state-level championships. After joining the IPS, Bedi served in Delhi, Goa, Chandigarh and Mizoram. She started her career as an Assistant Superintendent of Police (ASP) in Delhi, and won the President's Police Medal in 1979. Next, she moved to West Delhi, where she brought about a reduction in crimes against women. Subsequently, as a traffic police officer, she oversaw traffic arrangements for the 1982 Asian Games in Delhi and the Commonwealth Heads of Government Meeting 1983 in Goa. As Deputy Commissioner of Police of North Delhi, she launched a campaign against drug abuse, which evolved into the Navjyoti Delhi Police Foundation (renamed to Navjyoti India Foundation in 2007).

In May 1993, Bedi was posted to the Delhi Prisons as Inspector General (IG). She introduced several reforms at Tihar Jail, which won her the Ramon Magsaysay Award in 1994. In 2003, Bedi became the first Indian and first woman to be appointed head of the United Nations Police and Police Advisor in the United Nations Department of Peace Operations. She resigned in 2007, to focus on social activism and writing. She runs the India Vision Foundation. During 2008–11, she hosted a court show Aap Ki Kachehri. Bedi was one of the speakers in Bhagavad Gita Summit (from 10–14 December 2021) during Gita Jayanti at Dallas, Texas, US along with other notable personalities such as Swami Mukundananda Ji, Dr. Menas Kafatos, Mr. Shiv Khera, Brahmacharini Gloria Arieira and others.

Bedi took oath as the Lieutenant Governor of Puducherry on 29 May 2016, stating that she was aiming to make Puducherry prosperous through "trust, empowerment and accountability." One of the first practices she initiated as the Lieutenant Governor was to open the gates of Raj Nivas - the official residence of the Governor - to the public, thereby making it the "People's Nivas". She started an 'open house' process where the public could visit Raj Nivas from Monday to Wednesday at 17:00 to meet the Lieutenant Governor in person and have their grievances addressed. She undertook morning rounds on bicycle to inspect public amenities and interact with people.

Another project by Bedi has been 'Mission Water Rich Puducherry'. When she heard that the PWD did not have enough funds to de-silt water channels and the drains, she brought in community support in the form of CSR, connected donors with JCB machine contractors, and had the channels de-silted in short notice. Today, this model is being emulated across the country. Bedi has authored many books.

ACP Shri. Bhanupratap Barge is the Asst. Commssioner of Police, In-charge of Anti Terrorism Squad, Pune Unit. He was Posted in Mumbai from 1986 to 2005 and then, since 2005 in Pune. He is associated with many Social Organizations for better Police Public relations and involved in Anti Terrorist Activities.

He has received numerous awards namely the coveted Presidents Police Medal for Meritorious Service in 2009, D.G.s Insignia award by D.G.P. Maharashtra in the year 2003, He was the First Indian Police Officer who received Survivors Club Membership, an International Award for Action Against Terrorists and till date he has received over 430 awards.

He was rewarded for the Shootout at Lokhandwala complex operation where seven gangsters, including Maya Dolas were killed in 1991 and for the seizure of 220Kg Brown Sugar valued at Rs. 220 Crores in the International Market, for the arrest of Four Khalisthan Liberation Front Terrorist in 1993, (These terrorists were planning to kidnap Late Mr. Dhirubhai Ambani and the Grand Daughter of then Prime Minister P.V. Narasimha Rao, and also for the Encounter of Five Sikh Terrorists in 1995 at Bhandup Khindipada in Mumbai, an operation that lasted for over 16 Hours.

Till date he has carried out 19 Encounters' of criminals, Caught Gangsters, Pakistani I.S.I. Agents, Terrorists, White Collar Criminals and arrested 4 Top Ranking and wanted Naxalites. He refused Security cover offered by GR, Pune despite ISIS threats.

He has rescued more than 150 major and minor girls from sex rackets and detected more than 100 cases of High Profile Sex rackets. For the first time since the Peshwa Era, Deepavali Festival for Sex Workers was arranged under his able leadership in the Budhwar Peth Red Light area in 2013.

He was also deputed as a Personal Body Guard for high Profile dignitaries such as Mr. Balasaheb Thakre and Mr. Amitabh Bachchan.

**Padma Bhushan Shri. Anna Hazare ji**  
*For excellence in the field of Social Science*

Kisan Baburao "Anna" Hazare an Indian social activist led movements to promote rural development, increase government transparency, and investigate and punish corruption in public life. In addition to organising and encouraging grassroots movements, Hazare frequently conducted hunger strikes to further his causes—a tactic reminiscent, to many, of the work of Mahatma Gandhi. Hazare also contributed to the development and structuring of Ralegan Siddhi, a village in Parner taluka of Ahmednagar district, Maharashtra, India. He was awarded the Padma Bhushan—the third-highest civilian award—by the Government of India in 1992 for his efforts in establishing this village as a model for others.

Foreign Policy named him among top 100 global thinkers in 2011. Also in 2011, Hazare was ranked as the most influential person in Mumbai by a national daily newspaper.

During the Indo-Pakistani War of 1965, Hazare was posted at the border in the Khem Karan sector. He was the sole survivor of an enemy attack. During his fifteen-year career in the army (1960–75), [17] Anna Hazare was posted at several locations, including Punjab (Indo Pak war 1965), Nagaland, Bombay (1971) and Jammu (1974)

Anna has been instrumental in the transformation of village Ralegan Siddhi through various initiatives like Prohibition of alcohol, Grain Bank, Watershed development programme, etc. He also focused on facilities like Education, removal of untouchability through the Gram Sabha.

In 1991 Hazare launched the Bhrashtachar Virodhi Jan Andolan (BVJA, People's Movement against Corruption), a popular movement to fight against corruption [38] in Ralegaon Siddhi. In the same year he protested against the collusion between 40 forest officials and timber merchants. This protest resulted in the transfer and suspension of these officials.

In the early 2000s Hazare led a movement in Maharashtra state which forced the state government to enact a revised Maharashtra Right to Information Act. This Act was later considered as the base document for the Right to Information Act 2005 (RTI), enacted by the Union Government. It also ensured that the President of India assented to this new Act.

In 2011, Hazare participated in the satyagraha movement campaigning for a stronger anti-corruption Lokpal (ombudsman) bill in the Indian parliament. Known as the Jan Lokpal Bill (People's Ombudsman Bill), it was drafted by N. Santosh Hegde, a former justice of the Supreme Court of India and Lokayukta of Karnataka, Prashant Bhushan, and social activist Arvind Kejriwal. The draft incorporated more stringent provisions and gave wider power to the Lokpal than the government's 2010 draft. These included placing "the Prime Minister within the ambit of the proposed lokpal's powers".

Within a few days of Anna Hazare's first fast demanding a strong Lokpal (on 5 April 2011), supporters started a campaign known as "I Am Anna Hazare", which was similar to the "We Are All Khaled Said" campaign from the Egyptian uprising. During Anna Hazare's second fast, his topi, the cap which became synonymous with Anna Hazare, became almost a fashion statement. Sales of the topis hit an all-time high. Kiran Bedi recommended that the "I am Anna" topi be displayed whenever someone asked for a bribe.

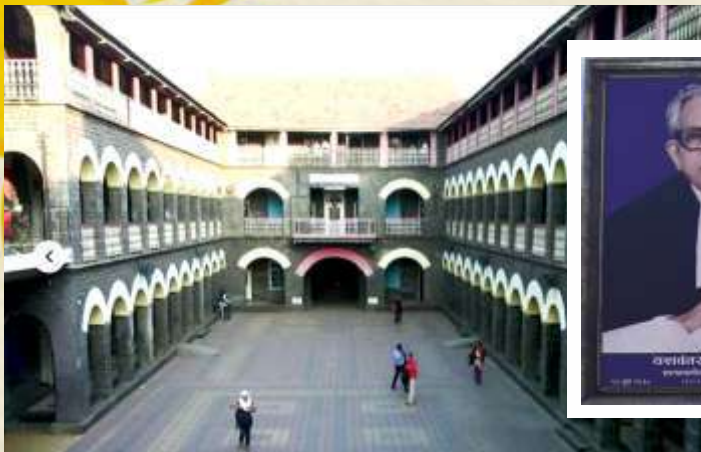

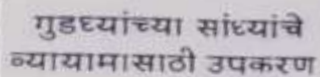

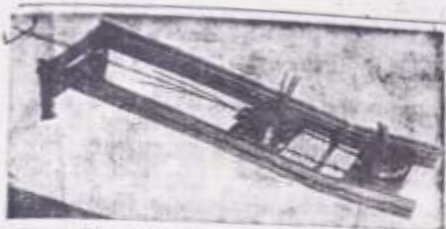

According to them patients can get paralysis due to wounds of the

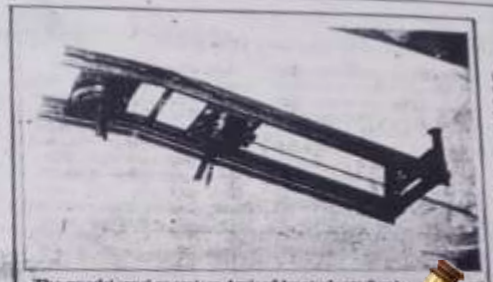

# RULES OF DISCIPLINE

- Students must be punctual and regular in attendance with minimum of 90% attendance of lectures held. It is mandatory for students to attend all the Seminars, Symposia, Workshops, Legal Aid Camps, Guest Lecturer and Other Co-Curricular activities organised by College, failing which they will not be eligible to appear the examination. No society or association of the students will be started without the previous permission of the Principal. No person shall be invited to address or entertain the students of the college without the previous permission of the Principal.
- Every student shall undertake to abide by Ordinance No. 157 of Savitribai Phule Pune University, Pune pertaining to maintenance of discipline and good conduct by students, as provided for under Ordinances framed under the Maharashtra Universities Act or such other laws in force.
- Every student of the college is provided an identity card. He/She should always carry it with him/her in and outside the college and should produce it whenever called upon to do so by the relevant authorities. No student of the college should travel without his/her identity card. Every candidate for the examination shall produce this card at time of university examination.
- The students are bound by all the rules and regulations laid down by the college from time to time. Any matter not expressly provided for in these rules shall vest at the absolute decision of the Principal who also reserves the right of modifying these rules as and when felt necessary. To safeguard its ideals of character and personal behaviour, the college reserves the right to expel any student at any time for any reason deemed sufficient by the Principal as misbehaviour in the institute.
- The Principal reserves the right to remove from the rolls the name of any student for failure to pay the college dues in time.
- Students are required to read the notices put up on the notice boards of the college. The college shall not accept any responsibility for any loss / damage incurred by a student owing to his / her failure to read the notice in time.

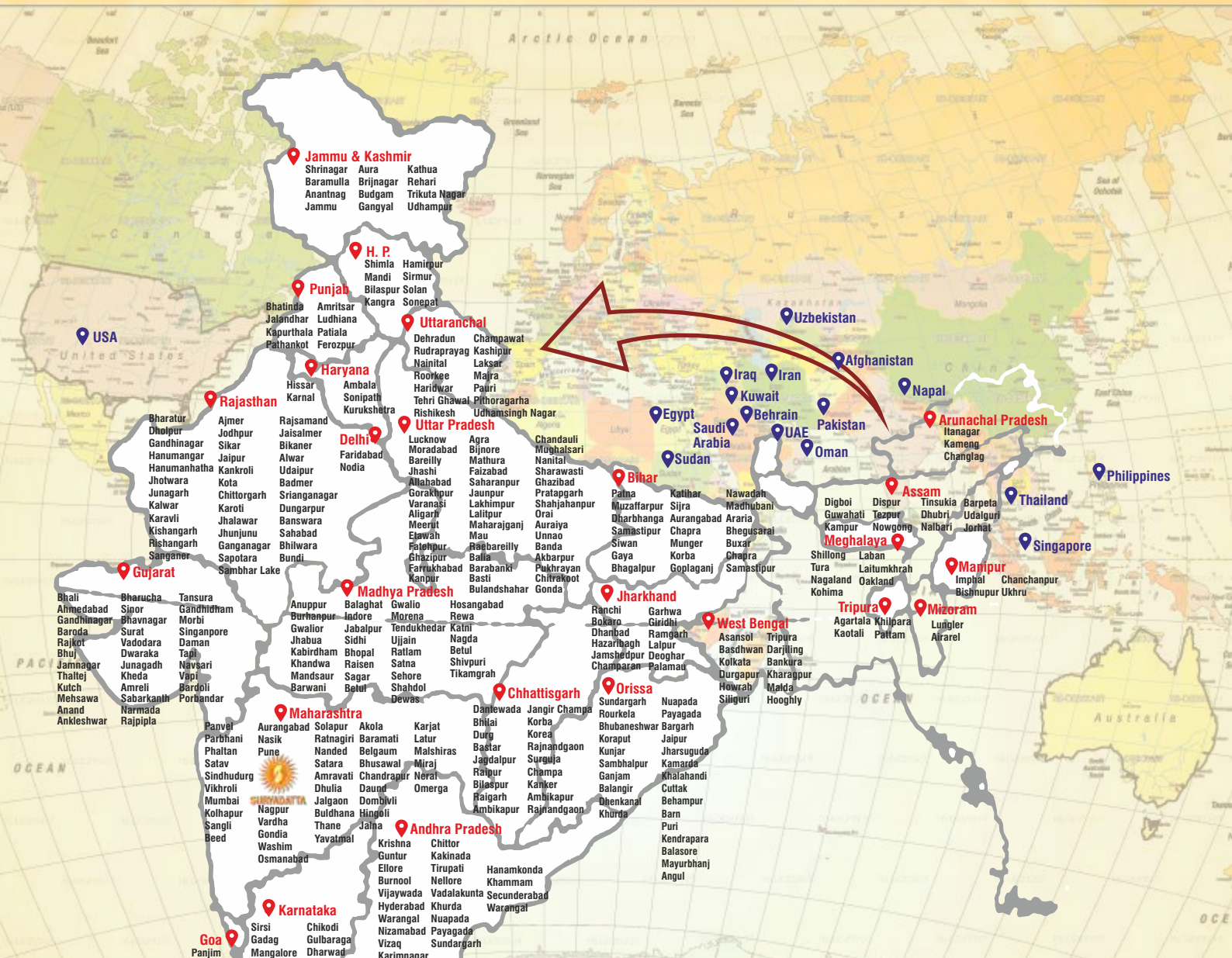
